1. Customer acknowledges receipt of tickets for the 2024 29TH Annual Gun Drawing. Drawing to include **93 guns, a 2024 Can Am Defender and 6 cash prizes of \$10,000**, to be given away on **July 20th, 2024** at the **Huntingdon County Fairgrounds, 10455 Fairgrounds Access Road, Huntingdon, PA 16652**. Price of ticket remains \$10/ticket. Consignor will ship additional tickets to customer upon request. **Dogs ARE NOT permitted on the fairgrounds.**
2. The Customer, at his/her own cost and expense, agrees to use its best efforts to sell tickets for the consignor on cash terms, and at such price as set by consignor, at no Lesser or Greater price.
3. Customer acknowledges that title to goods shall remain with Consignor until goods are sold.
4. Risk of loss of the goods shall be the responsibility of Customer while said goods are within his/her possession.
5. Either party may terminate this agreement, in writing, at any time. Within ten (10) days of termination, Customer will forward all monies due and all unsold tickets to Consignor.
6. All monies due and all unsold tickets must be returned to Consignor no later than **July 9, 2024**
7. Customer does acknowledge responsibility for any and all attorneys/collection fees, which may be incurred by Consignor in the collection of all monies and /or unsold tickets and agrees to pay the same.
8. Customer does acknowledge and agree that any and all legal actions pertaining to any part of this agreement will be litigated in Huntingdon County, Pennsylvania.
9. This agreement is not assignable and shall be modified only in writing.
10. This agreement shall be binding upon and specific to the benefit of the parties, their successors, assigns and personal representatives.
11. ***Upon receipt of this completed document, tickets requested, and any further ticket requests will be sent to seller as soon as possible.***
12. ***Consignment sheet will still accompany all tickets sent.***
13. ***Ticket requestor assumes full responsibility for any tickets given to other parties to sell on requestors behalf.***
14. ***Please provide your email address as we have new processing software that will allow us to provide updates and communications prior to and during the raffle.***
15. ***Watch our website for more information about the ability to view the status of all tickets that is associated to them, request additional tickets, and purchase tickets online.***
